Instructions to Voter

- **To vote:** completely darken the oval (●) to the left of your choice.
- Note the permitted number of choices directly below the title of each candidate office. Do not mark the ballot for more choices than allowed.
- If you mark the ballot for more choices than permitted, that contest or question will not be counted.
- **To vote for a write-in candidate:** completely darken the oval (●) to the left of the blank line and write in the candidate's name. Only votes cast for candidates who filed as write-in candidates can be counted.
- Do not write in a candidate's name if that person's name already is printed on the ballot for that same contest.
- **If you make a mistake or want to change your vote:** return your ballot to an election official and get a new ballot. You may ask for a new ballot up to two times. **Do not attempt to erase or cross out any marks made in error.**

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of Yorkville Village for the purpose of **current expenses** at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to \$0.15 for each one hundred dollars of valuation, for 5 years, commencing in 2022, first due in calendar year 2023.

**25 Proposed Tax Levy  
(Renewal)  
Warren Township Park District  
(Jefferson and Belmont Counties)**

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of Warren Township Park District for the purpose of **maintaining and improving recreational facilities** at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation, for 5 years, commencing in 2021, first due in calendar year 2022.

A majority affirmative vote is necessary for passage.

An additional tax for the benefit of Yorkville Village for the purpose of **police protection** at a rate not exceeding 5 mills for each one dollar of valuation, which amounts to \$0.50 for each one hundred dollars of valuation, for a continuing period of time, commencing in 2021, first due in calendar year 2022.




